

**MAB Awarded Most Innovative in Nation** 

The Master in Agribusiness program was again honored as one of the nation's best distance education programs. The program received the University Continuing Education Association(UCEA)/Peterson's Award for most innovative distance education program.

Dr. A. David Stewart, Assistant Dean for Program Development in the Kansas State University Division of Continuing Education, accepted the award at the association's annual meeting, April 7, 2001 in Philadelphia. On May 18, 2001, Dr. Stewart presented the award to the Department of Agricultural Economics during a luncheon in Manhattan. "The strong and creative team effort between the Division of Continuing Education and the department of agricultural economics has resulted in this outstanding program that continually earns national and international recognition," said Stewart.

The UCEA/Peterson's Award for Innovative Distance Education Programs recognizes a single higher education institution whose distance education programs exemplify the best in instructional design and effectiveness each year. The goal of the award is to recognize programs that improve access, quality, and costeffectiveness in higher education. The UCEA is an international association of more than 400 accredited universities and colleges, which provide undergraduate, graduate and professional education via the Internet, satellite television, independent study and other methods.
