## MAB students receive grants for thesis research

Two Master of Agribusiness students have received grants to fund their thesis research. Lautaro Perez Rocha, class of 2002, received \$5,000 from The National Meat Institute of Uruguay (INAC) and Doug Claussen, class of 2002, received \$3,500 from the Nebraska Cooperative Council.

Lautaro's thesis will assess the Chilean beef market and evaluate perceptions and preferences of consumers towards Uruguayan products. Doug's thesis will calculate a value created index for local farm supply cooperatives.
